## Corptax Certification Exam Dates and Renewal

To become a Corptax Certified Professional in any topic, you must successfully complete a knowledge exam and case study to ensure efficient and quality product usage. There are no prerequisites to sign up for a certification exam.


### Certification Fees

The certification fee is per certification topic. Fee includes unlimited attempts for the knowledge exam and two attempts at the case study. Subsequent attempts for the case study are available.

### Retake Policy

You are allowed unlimited retakes of the knowledge exam and one free retake of the case study. Subsequent test attempts for the case study incur a retake fee per exam. You must pass both exams within 6 months of each other.

### Renewal Requirements

- Complete 10 CPE credits from CCP-eligible training annually, beginning in 2021
  - CCP-eligible courses in this schedule include the following indicator: 
- Pass annual knowledge exam
- After three years, remit applicable certifications fees, and pass knowledge and case study exams, starting in 2025
